#### Minutes

Becky and Ebby were not able to meet to on this item so rather than delaying further, it was moved and approved to send \$1,000 to the Story County COVID-19 Emergency Fund for Immigrants and \$1,000 to Food at First.

#### **Ministry and Counsel**

- A letter has been written that would be sent to everyone currently on the Friends mailing list to see if they want to stay on the list. The draft was read and revisions proposed after which approval was given to send out the letter and accompanying material.
- For the time being, hybrid Meetings for Worship will continue with some Friends meeting via Zoom and others in-person at the Meetinghouse.
- Steven has been Clerk for one year and would like to discontinue his responsibility as Clerk. He Is willing to continue for another year if there is a clerk-in-waiting in place. This item will continue to be on the agenda.
- The question was raised about whether the Meeting should adopt a project or focus for the coming year. A suggestion was made that this focus be a more concerted partnership with or in support of ASIP (see additional notes on ASIP below).
